**III. Minutes – April 9, 2025**

The Commissioners adopted the minutes of the April 9, 2025 meeting as submitted by staff. Motion made by Commissioner Glenn; seconded by Commissioner Collins. Motion carried 6-0-0.

**IV. Chair's Report**

Chair D'Souza reported the resignation of Commissioner Howard Rosenblum and announced the appointment of new Commissioner Gregory Vaci. Chair D'Souza also welcomed the arrival of the new Edward Coles Fellows for the summer. Finally, Chair D'Souza discussed recent outreach events with the Consulate General of Ireland, the National Association of Young People Who Stutter, and the Illinois Asian American Legislative Caucus Foundation and Illinois Asian American State Employees Association.

**V. Staff Reports**

**A. Tracey B. Fleming, Executive Director**

Executive Director Fleming submitted a written report prior to the meeting. Executive Director Fleming congratulated Chair D'Souza and Commissioners Glenn and Kouri on their appointments advancing out of the Senate Executive Appointments Committee. Executive Director Fleming responded to questions about a meeting with the Community Justice and Civil Rights Clinic at Northwestern Pritzker School of Law, the submission of the Fiscal Year 2025 Strategic Planning Report, requests to the Department of Central Management Services for additional office and meeting room space, and recent updates to the Commission's case management system.

**B. Claudia P. Ortega, Chief Financial and Human Resources Officer**

Chief Financial and Human Resources Officer Ortega submitted a written report prior to the meeting. Chief Financial and Human Resources Officer Ortega discussed the current headcount and the number of remaining vacancies, provided an estimate on the Commission's budget lapse for Fiscal Year 2025, and confirmed the General Assembly passed the Illinois State Budget for Fiscal Year 2026.

**C. Brian Weinthal, Chief Administrative Law Judge**

Chief Administrative Law Judge Weinthal submitted a written report prior to the meeting. Chief Administrative Law Judge Weinthal introduced the new Edward Coles Fellows. Chief Administrative Law Judge Weinthal also announced the hiring of new Administrative Law Judges Pamela Curran and the retirement of Administrative Law Judge William Borah later in the month. Finally, Chief Administrative Law Judge Weinthal reported an increase in pending cases and responded to a question about updates to the standard forms used in the Administrative Law Section.
