# A Note from the Executive Director Philip Dalmage

Over the last few weeks, due to the Coronavirus Disease (COVID-19) outbreak, Governor Pritzker declared a Disaster Proclamation and the President declared a National Emergency. As the global effect of COVID-19 continues to evolve, the Illinois Human Rights Commission (Commission) is committed to the health and safety of the residents of Illinois and the Commission employees working tirelessly to serve our communities. The extent of COVID-19 in our state and across the country has become clearer, and more sobering. As with many public health issues, this one is both highly complicated and rapidly evolving. The Commission is closely monitoring the ever-changing protocols and complying with the Illinois Department of Public Health guidance.

However, to ensure the uninterrupted administration of justice to the residents of Illinois afforded by the Illinois Human Rights Act, the Commission will remain open to continue to service the residents of the State of Illinois. To do our part at the Commission, we have instituted intensified sanitation measures for all Commission staff. Where possible, we are allowing administrative and supervisory staff to work from home to reduce the concentration of people in our locations. We have eliminated community outings that involve gatherings with the public in keeping with social distancing. We are strongly encouraging parties filing with the Commission to file by first-class mail. If you have to file personally at the Commission Office please use our new filing procedures identified on the Commission website (www.illinois.gov/ihrc.)

Please also take note of the following:

- Filing by U.S. Mail: An item properly received by mail shall be deemed to have been filed on the date specified in the applicable proof of mailing. Proof of mailing shall be made by filing with the Commission a certificate of the attorney, or the affidavit of a person who is not an attorney, stating the date and place of mailing and the fact that proper postage was prepaid. The certificate or affidavit shall be filed with the Commission at the same time the item to which it refers is filed. If the certificate or affidavit does not accompany an item filed by mail, an item received by mail shall be deemed to have been filed when postmarked, properly addressed and posted for delivery. Commission Procedural Rule Section 5300.40(a). Service by mail shall be deemed complete four days after mailing of the document, properly addressed and posted for delivery, to the Person to be served. Commission Procedural Rule Section 5300.40(c).
- ♦ Weekly Request for Review Commissioner Panel Meetings: Weekly Request for Review Commissioner Panel Meetings have been cancelled through April 17, 2020. Please check the HRC website (www.illinois.gov/ihrc) for details regarding panel meetings beginning the week of April 20, 2020.
- Administrative Law Section (ALS) Hearings: Until further notice all ALS public hearings scheduled through April 17, 2020 have been rescheduled. If you have questions regarding your appearance at a hearing, please contact the Judges' clerk by calling 312-814-6269.
- ♦ ALS Motion Call, Settlement Conferences and Status Hearings: Until further notice ALS Motion Calls, Settlement Conferences and Status Hearings will be conducted telephonically. If you have questions, please contact the Judges' clerk by calling 312-814-6269.

## The Health and Wellness of our Guests and Staff is our First Priority!

Pursuant to Sections 5300.30 (Service of Pleadings) and 5300.40 (Filing) of the Commission's Procedural Rules:

### 5300.30

- a) Manner of Service. Unless otherwise provided, all motions, orders, notices and other pleadings required to be served under the Act or this Part shall be served either personally or by first-class mail.
- b) Proof of Service. Proof of Service shall be filed when service is required. Proof of service shall consist of the statement of the individual making service, specifying the manner and date of such service. If the Person making service is not an attorney, the statement shall be verified.
- c) Effective Date of Service by Mail. Service by mail shall be deemed complete four days after mailing of the document, properly addressed and posted for delivery, to the Person to be served.

#### 5300.40

All documents and pleadings required by the Act or this Part to be filed with the Commission shall be deemed filed when received in the Commission's Chicago or Springfield office. An item properly received by mail shall be deemed to have been filed on the date specified in the applicable proof of mailing. Proof of mailing shall be made by filing with the Commission a certificate of the attorney, or the affidavit of a person who is not an attorney, stating the date and place of mailing and the fact that proper postage was prepaid. The certificate or affidavit shall be filed with the Commission at the same time the item to which it refers is filed. If the certificate or affidavit does not accompany an item filed by mail, an item received by mail shall be deemed to have been filed when postmarked, properly addressed and posted for delivery.

During the COVID-19 outbreak, in an effort to keep everyone healthy, we strongly encourage parties filing with the Commission to file by <u>first-class mail</u>. If you have to file personally at the Commission Office please use the hand sanitizer provided by the Commission upon arrival, submit all originals, and copies, in the basket clearly marked "Filings," and ensure all documents are date-stamped accordingly. Hand sanitizer and a date-stamp will be provided alongside the basket marked "Filings."
